# **AARP TAX PREPARATION**

For federal and state returns, Call 961-1149 (Recreation Center) to get started. This free service provides electronically filed returns (unless you have a unique situation) It is an AARP/IRS approved, computer program (Tax Wise)--an UP-TO-DATE, SECURE, and PRIVATE Service open to all.

Hours: Noon to 7 p.m. each Monday and Wednesday. Those needing service who have difficulty traveling from Warm Hearth should contact **Frank Lau** at 961-0516 for a Warm Hearth visit.

AARP DRIVER SAFETY



Our two programs are filling up fast: **Mar 29** and **31**, (Wed and Fri) from 1 p.m. to 5 p.m. Blacksburg Community Center, **OR Apr 19** and **21**, (Wed and Fri) from 1 p.m. to 5 p.m. Warm Hearth.

**REGISTER** by calling **Jim Gaines** at **552-6851** to sign up for an AARP Driver Safety Class. First come, first serve to a maximum of 20.

Sessions begin promptly at 1 p.m. and are held four hours each day. Students **must** attend both sessions to graduate and obtain a certificate. The certificate is evidence for your insurance discount. Cost is \$10 per person payable to AARP.

Attendance is limited to the first **20 persons** who apply and you must be 50 years of age or older--only those over 55 can receive the insurance discount.

# LEGISLATIVE UPDATE

<u>NATIONAL</u>: AARP plans to ask Congress to change the new Medicare prescription drug program by changing the rule that counts assets such as a house, in determining Medicare patients being poor enough to qualify for special low-income subsidies. They also want to allow health officials to negotiate directly with drug makers over the prices they charge through the program.

The recently passed budget makes cuts in Medicaid and Medicare and will make it more difficult for people to transfer assets to enter nursing homes funded by Medicaid. The Congressional Budget Office projects by 2010 that 13

million low-income people will face higher co-payments for medical services. Savings are projected because large numbers of low income seniors and children are expected to cease seeking medical care because of the higher costs.

President Bush's proposed new budget for 2007 calls for additional cuts in Medicare and Medicaid over the next five years including payments to hospitals, a freeze on payments to using homes, home health agencies and oxygen providers. He also wants higher income seniors to pay higher Medicare premiums beyond the increased payments already scheduled for 2007. He also proposes controversial health savings accounts.

STATE: AARP supported bills are still in committee including the pay day lending bills. Efforts are being made at some compromise over these. Bills calling for dramatic changes in Medicaid appear to be heading for a one year study by the responsible agencies.

The Caregiver Grant Program bill has been amended to increase the grant available to a caregiver of a mentally or physically impaired relative from \$500 to \$1,500. It is a concern to Virginia AARP that the focus on transportation spending may come at the expense of urgent demands on core services, including the long term care needs of seniors.

A repeal of the *estate tax* would result in a substantial reduction in state revenue that will have to be made up somewhere else.

- 1. President McDaniel called the meeting to order at 9:03 a.m. and those in attendance viewed the video "AARP Chapters A Community of Service Since 1960". Jim Moore made a motion to continue using the current room for AARP Board meetings. Allen seconded, and the Board voted to continue using the same space for meetings.
- 2. McDaniels asked to add the Town of Blacksburg Comprehensive Plan to the agenda.
- **3.** The Board approved the January, 2006 **minutes** unanimously.
- **4.** Allen, Treasurer, distributed a **financial report** for January 2006 showing an ending balance of \$2,974.94. McDaniels accepted the report for the record.
- **5.** Oliver, Chair of the Financial Planning Committee, presented the **proposed 2006 budget** based on 315 members. He explained that the Health and Wellness Fair is not a regular part of the budget. A motion was made by Ben Crawford to approve the budget as presented with an expression of thanks to Oliver for his hard work. Elson seconded and the motion passed unanimously.
- **6.** McDaniels introduced new chairpersons, **Nancy Eiss, Public Relations; Mike Sporakowski, Community Service; Harriet Damant, Health Care; and Al Crawford, Ways and Means**. A discussion was held on possible community partnerships and community service projects. All of the following organizations who were contacted by AARP members stated that they would like to become a community partner with AARP: *The Christmas Store, The Interfaith Food Pantry, Free Clinic of the NRV, The Women's Resource Center, Habitat for Humanity* and *RSVP*. Potential projects include: Help with Medicare Part D RX, Ramp Improvements, Clean-up Parks in Blacksburg, Increased Caring for Members, Medical and Meals Transportation, and Sponsoring a Health and Wellness Fair. Ben Crawford offered to have the Ruritan Club co-sponsor the Health and Wellness Fair because they have an automatic liability insurance policy. A motion was passed by the Board to have McDaniels and Little explore the insurance needs and issues for the Health and Wellness Fair and potential projects of the Chapter.
- 7. Wightman, **Membership Chair**, distributed a report stating that 45% of the membership has renewed their dues as of February 1, 2006. Anderson has made name badges for all members. One of the ideas to increase membership is to offer a lifetime membership for \$100. A motion was made, seconded and carried by acclamation to offer the lifetime membership of \$100 per person.
- **8.** Cooper, **Program Chair**, reported that the February 21 meeting will be co-sponsored with the League of Women Voters and Meghan Dorsett will give a presentation on the Montgomery County Comprehensive Plan. It was decided to leave the April 18 meeting open for possible local election issues. The Health and Wellness Fair is scheduled for September 19, 2006. A White Elephant Sale will be arranged sometime during the year (probably as part of June 20 Picnic).
- 9. Ben Crawford, Newsletter Chair Co-Chair, stated newsletter deadline for articles is this Friday.
- **10. AARP Virginia Events** are: February 13 Day at the State Capitol; April 20 "Smart Choices" Workshops Blacksburg, Custom Catering; May 11 Day of Service



- 11. Jim Gaines has 15 signed up in each "Driver Safety" class. Frank Lau has begun serving clients through the Town of Blacksburg Senior Center for AARP Tax Aide.
- **12.** Fleming, **Legislative Co-chair**, presented information prepared by Finch, Mitchell and himself on the **Estate tax repeal**. He distributed copies of a letter sent to the VA Senators by the state AARP Director and President expressing the AARP position.

He also gave the national and state level issues adopted by AARP. He recommended that the Board endorse the state AARP position opposing the repeal of the estate tax. Cooper made the motion, Finch seconded and the motion passed unanimously. Gaines, **History Chair**, presented the final draft of the Chapter's 30-year history to Ben Crawford for review.

- **13.** Schmidt reported on the **Volunteer Recognition Celebration**, which is scheduled for Saturday, April 1 at the Blacksburg Community Center. Since Elson is serving on the planning committee, he relinquished his vote to McDaniels and Moore to nominate the candidate for the AARP Chapter. Mary Ellen Moore, the **Hospitality Committee** Co-chair, volunteered the committee to assist on the day of the event.
- **14.** After discussion on a date that a representative from the Town of Blacksburg could give a presentation on the Comprehensive Plan, the Board decided to postpone a presentation until a later date. Ron Gaysunas has requested to act as an AARP Chapter spokesperson on the Medicare Part D issues. It was decided not to grant authorization to have a chapter spokesperson on this issue. The meeting was **adjourned** at 11:12 a.m.
