Dan Level will present a sampling of devices that make tasks in daily life easier. In most cases, a variety of devices can greatly increase an older person's ability to stay in their own home independently and safely. For example, round door knobs can be hard for some people to grasp. A round door knob extension can be snapped to any round door knob transferring it into an easy to use lever. Other examples are a needle threader, key turners, giant push button telephone index, lifter seat, plug puller, cardholder and many more. There are literally thousands of devices that may be of assistance. The devices that

Dan will show and demonstrate can improve or enhance :

- moving about home or community;
- preparing meals and eating;
- personal care and grooming:
- housekeeping and yard care;
- recreation and hobbies; and
- > transportation.

Persons of all ages and functional abilities can benefit from these devices called Assistive Technology. The devices shown should help you start thinking about what devices might help you. Be more independent in your own residence and in your travels by benefiting from Assistive Technology. This program is offered by AARP VIRGINIA with help from the Virginia Assistive Technology System, Virginia Department of Aging, Virginia Center of Aging, Virginia Association of Area Agencies On Aging, and the Virginia Department of Social Services. This is a meeting you won't want to miss. It will be helpful, educational and fun.

The membership meetings are held at the Blacksburg Community Center on the third Tuesday of each month except December, July and August. Be sure to make a special effort to attend and remember to bring a friend and your lunch. We begin eating our bag lunches at 11:30 a.m. (coffee and tea available) with the program following at noon.

Again, this February, the AARP Tax-Aide program will be preparing tax returns under the name of Tax Counseling for the Elderly. As in years past, there will be a group of preparers who have passed the IRS test, at the Blacksburg Recreation Center. The service is as always, free of charge for the preparation of Federal and State tax returns.

As always, we ask those with rental properties, or who are in business for themselves, to consult a paid preparer, for they are not within our certification. Those with

amended returns, or back taxes, estate, trusts, or partnerships should also seek paid help.

This AARP service will start the second week of February. So as you receive your 2003 tax documents, keep them together, along with medical, and charitable receipts, keep them ready for us. We also offer help for those wishing to work on their own.

President Brian Allen called the November 4, 2003 board meeting to order. The agenda for the meeting and minutes of the October 7, 2003 board meeting were approved.

Information and Items of Interest or Business

Treasurer's Report: Ray Murley.

The balance, including everything in the account, was \$1,926.77.

Harriett Cooper moved that members be asked to bring nonperishable food items for the food pantry to the November meeting. The motion was seconded and passed. Jim Moore agreed to transport the food to the food pantry.

June Schmidt gave a financial report on the Volunteer Recognition Celebration which our chapter has sponsored two times. The balance to carry forward was \$598.12. June moved that our chapter sponsor the Volunteer Recognition Celebration for 2004. The motion was seconded by Jim Moore and passed. Darrel Clowes moved that our chapter provide financial support for the 2004 Celebration. June Schmidt seconded the motion and it passed. A motion was made and passed to table the question of financial support for the 2004 Celebration until the January 6, 2004 board meeting. June will work with Ray Murley on the financial details.

Legislative: Dan Fleming reported that the tax reform study prepared by his committee has been forwarded to the Governor and he noted that the Speaker of the House has stated there will be no new taxes next year. An Intergenerational Conference on Aging will be held December 4-6 in Washington, DC. Anyone interested in attending should contact Brian Allen.

Brian Allen passed around a plaque received by the Blacksburg AARP Chapter for 25 years of service. Ray Murley will ask if our chapter can display plaques at the Senior Center.

Jim Moore is working on our chapter's by-laws. The group was asked to study the proposed changes and make recommendations to Jim.


The Mount Tabor Ruritan Club has donated \$100 for the 55 Alive program. Ben Crawford will talk to the Club about how this money can be used.
