President's Column



Why We Need AARP

As I listened to the speakers' presentations and answers to questions at the chapter forum on Social Security August 30th, it struck me what a complex issue Social Security is. It caused me

to reflect on how difficult it would be for each of us, individually, to understand and talk in an intelligent manner to our elected representatives on this important topic. Fortunately, we have experts employed by AARP that can help us with the issues. National AARP has the collective resources of 40 million members that can be used to hire true experts on Social Security or any other significant issue important to those of us 50 years old or older. For example, Medicare is even more complex than Social Security.

After accurate information has been shared about Social Security, the next step is to determine what stand to take on the issue. AARP will be surveying its membership to determine this direction. The step after determination of the position on the topic will be to inform and work with the real decision makers on Social Security - the members of Congress. At the right time AARP will ask the membership to express our opinions to both U.S. Senators and our Congressman. Let's make certain we do just that and use the information AARP shares with us to make an intelligent choice on a complex subject and share that choice in a timely manner.

A second area where it is an advantage to have AARP is community service. The current example (co-sponsored with Ruritan)

is the *Drive to End Hunger*. The first is the Annual Enrollment Period for Part D Medicare Prescription Drug Plans running from October 15, 2011 through December 7, 2011. This comes a month earlier than previous years. It is important to remember as this is the only time of year that Medicare beneficiaries can make changes unless certain other criteria are met. All plan changes made during the Annual Enrollment period become effective January 1, 2012.


During the Annual Enrollment Period. Virginia Insurance Counseling Assistance Program Coordinator, and volunteers with the Agency on Aging work with Medicare beneficiaries to research plans. appointments, and enroll schedule Medicare beneficiaries choose requested. from the best suited plan for them based on their personal prescription profile and other considerations. Previous participants will receive mailers beginning in September to start the enrollment process and anyone can call the Agency on Aging (980-7720) to schedule a counseling appointment. Sessions will be held throughout the New River Valley. All VICAP staff and volunteers are trained and certified to provide insurance counseling and this is a free service to all Medicare beneficiaries regardless of income.

Blacksburg AARP Chapter Hosts Social Security Forum

A crowd of 175 concerned senior citizens attended a public form on Social Security hosted by the Blacksburg AARP Chapter at Warm Hearth Village. Two Social Security experts, Allen Barrow Public Affairs Specialist for the Social Security Administration-Roanoke Office and Bill Kallio AARP Virginia State Director, shared insights on the current Social Security program and its future. Their presentations were followed by a question and answer period.



Among points emphasized by the speakers concerning Social Security (SS) were:


- · SS is not in crisis
- · SS is an earned benefit
- SS does not contribute to the Federal deficit
- 67% of SS beneficiaries are retired, others are disabled and survivors
- 93% of workers are covered under SS
- Average monthly benefit for a retired worker is \$1,175
- For 23% of older Americans SS makes up 90% of income
- SS Trust Fund must be invested in U. S. Treasury Bonds
- Trust Funds are backed by the full faith and credit of the U. S. Government
- Without changes by 2025 benefit expenditures will exceed income
- Without changes by 2037 Trust Fund assets will be exhausted and only tax revenue will be used for benefits

Future Solvency Options

- Increase level of earnings subject to payroll tax
- · Increase payroll tax
- Include newly hired state and local government workers
- Diversify investments of assets in Trust Fund
- · Increase retirement age
- · Decrease benefits for higher earners
- Increase number of years in benefit calculation formula
- Change how past earnings are adjusted in benefit calculation
- Change basis for annual cost of living allowance (COLA)

It was stated that National AARP has not taken on specific ways to modify Social Security, but will soon be surveying membership to determine actions to recommend to Congress, which will have to approve of any future changes.

Call to order--President John Hillison called the meeting to order at 10:05.

Officers Present: President John Hillison, Vice President Don Creamer, Secretary Virgil Cook, Treasurer Brian Allen

Approval of Minutes--Don Creamer moved that the minutes for the June meeting be approved. The motion passed.

Treasurer's Report—Brian Allen. The report covered June through August. Balance at the end of May, \$2,095.77; balance at the end of August, \$2,137.61; balance in the reserve account, \$2,677.91. We made a \$100 donation to Warm Hearth for Founder's Day. We made more money from the auction than in past years, \$285. Sue

Farrar move that the report be received. The motion passed.

Officer's Report—John Hillison. The forum on Social Security at Warm Hearth was quite successful. Estimates of the number of attended ranged from 172 to 175. Seventy-one of the attendees were national AARP members but not members of our chapter. John suggested sending copies of the September newsletter to these people.

Membership—Tom Alston. We have had two new members since the last report. Our total membership is 350.

Legislation--Ben Crawford. The message at the Social Security forum at Warm Hearth was that Social Security and Medicare must be protected. Blaming SOCIAL SECURITY for financial problems is unfounded. If nothing is done, the fund should be solvent until the 2030s. Attendees were invited to sign a petition urging that Social Security be protected. More than 50 people signed the petition.

Senator Warner sent a key person on his staff to the program. Neither of our state delegates were there. There were no newspaper reporters at the forum. Warner's aide also had a booth.

Ben distributed a list of questions that AARP would like to ask General Assembly members. The list gives AARP positions on each item.

Programs--Carl McDaniels. September 20—Candidates Forum for Montgomery County Board of Supervisors—— District E-F-& G Invited. Mary Biggs is running unopposed. We may have only three candidates. Town Council members will be present for the October forum. The board agreed that we should invite School Board candidates to the September 20, chapter meeting. The Montgomery County Christmas Store will present the program in November.

Newsletter—Edd Sewell. In the last newsletter, Edd tried to emphasize the SOCIAL SECURITY forum and the food drive.

Chapter Awards—Nita Wightman. Awards will be presented at the Christmas luncheon.

Caring—Margaret Kates. Margaret thanked members for notifying her of people who need cards.

Driver's ED--Curt Finch. Thirteen people participated in a course in New Castle. There will be a course on October 12-13. Five people have already signed up, which is very good for so early

in the sign-up period. State law mandates a discount on insurance for three years.

History—Doris Abraham. There was an article about Joanne Underwood in the June Senior News as well as an article on Jim Wightman's participation in a triathlon.

Hospitality—John Hillison observed that we need help with coffee at chapter meetings and with the Christmas lunch.

Community Service and Create the Good—Sally Anna Stapleton. There will be food drives on Friday and Saturday at both Blacksburg Kroger stores and at the Ruritan fish fry. We need volunteers for the Kroger stations to work in two-hour slots. Some of the canned foods will go to VT Engage. No glass containers are permitted for the food pantry. They break too easily.

Nominating Committee--Sue Farrar. The committee will put forth nominations for the three officers and three board members. The formal nominations are made at the October meeting and voted on at the November meeting.

Liaison—Ben Crawford. Ben emphasized the collection of food donations at the Ruritan Fish Fry. The truck from the Food Pantry will be there beginning around 2:00.

Ben reiterated AARP's policy on elections. AARP does not endorse candidate of either party, and it does not contribute to campaigns. It does, however, encourage people to vote, it does take stands on particular issues such as Social Security, and it publishes voter-education materials. Chapters can invite candidates to speak, but they must treat all candidates equally and fairly. Members should not help candidates if such help might be construed as working for AARP.

New Business

John Hillison said that he would like to donate to each organization that gives programs for us. He recommended \$100 to each partner and \$600 to the Community Center for a total of \$1300. Don Creamer move that the chapter donate \$1300 to the seven partners and the Community Center. The motion passed.

The picnic went well. We made \$285 on auction.

Free Clinic Tours—Don Creamer reported that the Free Clinic is offering tours as a means of calling attention to its work. He recommended promoting the tours.

Adjournment—The meeting was adjourned at 11:35.
